RE: VOC Emission Testing; CDPH Standard Method v1.2; non-full spread applications calculations

Below are the rationale and the calculations for the quantity of Hilti CP572 Smoke and Acoustic Spray that would be used in the standard classroom and the standard private office as defined in the CDPH Standard Method v1.2 – 2017.

CLASSROOM

The dimensions of a typical classroom are given by the CDPH Standard as: 40' x 24'. The CP572 is applied using a sprayer to a width of 8" and a thickness of 1/8".

Sealant cross-sectional area = 8" wide x 1/8" thick = 1 square inch

Sealant length = 40'+40'+24'+24' = 128 feet

Volume required = 128 feet x 12 inches/foot x 1 square inch = 1536 cubic inches = 6.7 gallons

Volume of container = 5 gallons

OFFICE

The dimensions of a typical office are given by the CDPH Standard as: 12' x 10'. The CP572 is applied using a sprayer to a width of 8" and a thickness of 1/8".

Sealant cross-sectional area = 8" wide x 1/8" thick = 1 square inch

Sealant length = 12'+12'+10'+10' = 44 feet

Volume required = 44 feet x 12 inches/foot x 1 square inch = 528 cubic inches = 2.3 gallons

Volume of container = 5 gallons
